
#### **Primary Care Webinars**


The European Forum for Primary Care (EFPC) hosted the first of multiple webinars on 17 November, 2016. Peter Groenewegen, Executive board member of EFPC and professor at the Netherlands Inst Health Service Research (NIVEL), presented primary care models for tackling multi morbidity via the online platform GOTOMEETING. Based on data from the ICARE4YOU study, Peter Groenewegen explained differences and similarities in primary care among European countries. He introduced the Spaghetti-Model (Vilans, 2011) to illustrate common public health strategies in tackling single and multiple chronic diseases of patients. In many European countries often one or two chronic diseases are targeted by Disease Management Programs (DMP) whereas primary care focuses on case management, as can be seen in the graphic. Peter Groenewegen demonstrated this is more cost effective and enhances well-being, health and the experience of patients when using healthcare. It was observable that EFPC is promoting a case management approach and shares a mutual ground with the basic principle of client-centeredness within Occupational therapy. The last 15 minutes of the presentation were open for discussion and many questions of participants could be answered. For interested professionals, two upcoming webinars are already scheduled:

## **Experts representing COTEC at the SciencelBusiness and Healthy Measures event**

The data challenge:

On Friday 16th December 2016, Dr Alison Laver-Fawcett (from York St John University) represented COTEC and OT-EU Research at the SciencelBusiness and Healthy Measures event: 'The data challenge: how and why do we measure patient outcomes'. The event brought together clinicians, researchers, chief medical officers, policy analysts and colleagues from the UK National Health Service (NHS), universities, medical schools, businesses and charities from across the UK and several European countries. Felix Faucon, Inspector General, Inspection generale des affaires socials, French Ministry of Social Affairs and Health and member of the EU expert Group for 'Health systems performance assessment' shared the French approach to measuring outcomes and Annemarie Haverhals, Programme Leader for Value Based Health Care, Senteon, discussed a project involving seven hospitals in the Netherlands. Whilst Ian Forde, senior policy analyst at the Organisation for Economic Co-operation and Development (OECD) talked about the challenges of bringing together health outcomes data from member countries.

Alison was the only occupational therapist and allied health professional (AHP) attending this event and was able to feed into the discussion the importance of focussing on outcomes that are meaningful and important to the person (client / patient), the need to be more effectively recording therapy outcomes and to consider outcomes from across the whole pathway, not just from hospital base care. When the meeting focussed on what the barriers are to clinicians routinely undertaking standardised outcome measures, she mentioned the lack of funding for clinical utility and face validity studies, and the importance of ensuring that measures are not just reliable and valid, but also acceptable to clients / patients and clinically useful for clinicians.

The importance of live tweeting was demonstrated as Alison was actively tweeting at the event and included @COTECEurope in many of her tweets. This raised awareness of COTEC during the meeting as a number of her tweets were retweeted, nine colleagues at the meeting started following her tweets and it resulted in some colleagues making contact at the networking lunch after the meeting, as a result of the tweets.

The main focus of this meeting had been on medical outcomes from hospitalised care and a debate about the value of recording process versus outcome measures. It is critical for occupational therapists to attend and contribute at events of this nature, to raise awareness of occupational therapists' contributions and to advocate for the people (patients/ clients) we serve. By the end of the meeting there was some agreement that both outcomes and process measurement is needed and that we should be measuring health and quality of life outcomes across the whole pathway, including community care settings.

Occupational therapists can continue to contribute to the discussion using hashtag #datachallenge. Healthy Measures is a specialist journal, produced by Science|Business, about the emerging role of patient data in health-care management.

#### WHO Europe Region and collaboration in Mental Health

On December 19th president Stephanie Saenger attended the *Third Meeting WHO-Europe and Staff groups active in mental health in the European region* in the UN-City in Copenhagen.

This time the consensus document was finalised and will be available as soon as all the logo's of the organisations and the references will be put on. The document will be published on websites and in journals of participants and members. Members will be encouraged to use the document and initiate collaboration on a national level.

There were very interesting and clarifying discussions about the similarities and differences in ethics and terminology of the participating professions. Not only do professions use other wording but interpret them differently too. Some of the next steps to take are the publication of a joint article in British Medical Journal and a policy document on identified priorities in mental health which we will jointly promote. During the meeting Martin Ward invited all to participate to join the panel in the Horatio Festival to show the collaboration in person in Malta. ## 4th HORATIO European Festival of Psychiatric Nursing

President Stephanie Saenger was invited to present a key note speech at the bi-annual four-day congress of HORATIO (European Psychiatric Nurses) organised in collaboration with the Maltese Association of Psychiatric Nurses (MAPN) in Malta Thursday 11th till Sunday 14th of May 2017. Martin Ward, president of HORATIO, expressed his wish for representatives from the different professional groups to participate as part of the intended working relationships, during the meetings of Staff groups working in Mental Health (WHO Europe). The topic of the speech will be: "What does Working in Partnership mean for Occupational Therapists". In addition to this Stephanie will take part in a one-hour panel discussion with the representatives of the other professional organisations.

One of the other keynote speakers is Dr. Tor Levin Hofgaard, president of the Norwegian Psychological Association and Executive Council member of the European federation of Psychologists' Associations (EFPA).

At the moment the Maltese Association of Occupational Therapists (MAOT) and COTEC president are discussing possibilities to organise some high level meetings with local authorities to promote OT in particular in mental health as a master plan for mental health is being devised in Malta. Suggested are mental health services CEO, the Commissioner for Mental Health, the Director for Allied Health Services and potentially the Minister of Health.

COTEC, MAOT and former EXCIE member Maria Daniela Farrugia are planning a poster presentation about OT and collaboration in Mental Health on European, National and clinical level.

In this way promoting OT to other professionals, stimulating collaboration and supporting OT in Malta can be combined.

The call for abstracts was announced on the COTEC website and send to the Expert Group Mental Health of the COTEC Register of Experts; we would like to encourage Occupational Therapists to submit abstracts and to participate in the Festival.




## The contribution of Occupational Therapy in Psychiatric Treatment

The Department of Occupational Therapy of the Metropolitan College in Greece participated in editing and writing of the newly published book concerning the contribution of Occupational Therapy in Psychiatric Treatment.

The title of this collective work is "The Contribution of Occupational Therapy in Psychiatric Treatment" and it was published under the supervision of the First Psychiatric Clinic of University of Athens. This collective work will be a valuable guide for students and practicing OTs in Greece. The publication of this book fulfils part of the vision of the Occupational Therapy department of the Metropolitan College on high quality-evidence based education for occupational therapists in Greece.
