

Call for Nominations of the Executive Committee for the Council of Occupational Therapists for the European Countries (COTEC) 2022

Dear Presidents, Representatives and COTEC Member Associations,

The 10th COTEC General Assembly will be held on October 1, 2022. Our hope is that it will go live after 2 years of online General Assemblies.

In short, according to the COTEC Constitution, the Executive Committee of COTEC consists of 6 positions. The term of office is four years with a possible re-election term of two years.

Number of positions to be elected during this year's General Assembly is three (3). 1, due to end of term and two from resignations due to personal reasons as you are informed in the March Newsletter

These positions are:

1. Vice President Finance: Eva Denysiuk, end of term
2. Vice President Administration: Sarah Mead Warren, stepped down
3. Member of the Executives: Blandine Parc, stepped down

Nominations for these positions are now open to all Member Associations.

- All Occupational Therapists who are members of a COTEC Member Association are electable.
- Every National Association can nominate one or more candidates of their own or together with other associations.
- It is recommended that the Executive Committee represents different regions within Europe. Therefore, we encourage you all to think about suitable nominees from their own country.

The roles and responsibilities of the Executive Committee are determined in the Rules of Procedures (see attachment 1). Each nomination should include the Nomination Form (see attachment 2). Please note that all documents required to support the Nomination Form should be attached and sent together with it. Please also note, that the nomination should be supported by persons/organizations/groups from at least two different countries to ensure the candidate has international contacts. As the working language of COTEC is English, all documents are required in English.
