#### President's Editorial

Since I wrote my first editorial in December 2013, 4 newsletters have been issued and the 3rd General Assembly (October 2,3 in Latvia) is coming up. How time flies and how many actions are taken! The Executive Committee (EC) is regularly updating the Action Plan 2015 and has started work on the new strategic plan for 2016-2020. The draft strategic plan will be available for discussion with members during the Governance Day, to be adapted, finalised and then presented and voted on in Galway. Based on the positive feedback of the meeting in Nijmegen, the EC has decided to continue with a full Governance Day and the round table discussions about 4 or 5 issues that are of interest for all members, important for the future of OT and the actions of COTEC.

I ended my first editorial with "All for OT!" At the moment there are only 5 Executive Committee members, since the sixth member resigned in December 2014. The five remaining members have many commitments to their employers and/or personal responsibilities and therefore have limited time to give to voluntary work for COTEC and are in need of additional voluntary support. I am happy to say that quite some associations and/or individual occupational therapists have shown active involvement with the COTEC work.

Already one third of the member associations have nominated experts for the Register of Experts as you can read in this newsletter.

Another great help has been the work of Patric Duletzki regarding the Summary of Profession and his participation in the conference on Mobility of Health Professionals in the EU — Ethical Recruitment and Policy Coherence on May 5th in Brussels. (report in this newsletter)

As there are so many important and interesting things going on it is very helpful if occupational therapists are willing to represent COTEC, like Ingrid Sturkenboom EPDA project.

Another way to have more impact and to get our voice heard is to collaborate with others especially clients groups. Therefore I was very pleased to attend the conference and campaign launch on Patient Empowerment organised by the European Patients Forum which invited COTEC to join.

And finally we are very happy to have commissioned the webmaster of the new ENOTHE website, who is able and willing to build the COTEC website along the same lines. This new website will be launched in October together with the new logo for COTEC.

As you can see, in spite of our significant challenges, it's been a productive time.

## COTEC and ENOTHE strategic planning

**ENOTHE**

COTEC, like ENOTHE, is developing its next Strategic Plan 2016-2020. The COTEC-ENOTHE Link person, Anne Lawson-Porter, shared with the COTEC Executive Committee the work that ENOTHE had started in Austria in January. In developing the two strategies further it became apparent that the political background that we are working in is virtually identical. Also, as both organisations rely on their members and also require good governance procedures, two strategic aims for both organisations are complimentary. Whilst this approach was not strictly intentional it is apparent that approaching it this way demonstrates that our concerns are often the same, except ENOTHE concentrates more on education and COTEC on practice issues. The developing thinking about this approach is that as external stakeholders look at our websites via a joint portal (in the process of being developed), they will recognise that our key intentions are broadly similar and our specific interests are complimentary. We hope you agree! These two strategies might underpin our continued thinking about the development of the OT Europe concept.

## Conference and Campaign Launch on Patient Empowerment

The President of COTEC was invited to the Conference and Campaign launch of Patient Empowerment (PE), organised by the European Patients Forum (EPF) held on May 20-21, in Brussels.

During this conference, speakers from different fields gave their view on PE. Patient empowerment was presented as one of the key elements to change the health systems towards sustainability. The meeting provided the opportunity to be informed about the state of the art in PE and to inform other delegates and organisations about Occupational Therapy and the OT perspective on PE, this being one of the core values of OT and which was acknowledged by a number delegates.
